

**ACKNOWLEDGMENT OF DANGER; RELEASE AND HOLD HARMLESS AGREEMENT**

**GOLDWATER AIR FORCE RANGE VISIT**

**PRIVACY ACT STATEMENT**

**AUTHORITY:** 10 USC 8013

**PRINCIPLE PURPOSE** Indicates certification by an individual or corporation to hold the U.S. Government and any Goldwater Air Force Range Lessee or lessor harmless in consideration of permission granted by the U.S. Government to visit the Goldwater Air Force range complex.

**ROUTINE USES:** Used to gain recreation access to the Goldwater Air Force range complex.

**DISCLOSURE IS VOLUNTARY:** Failure to provide this information would result in an individual being denied access to Goldwater Air Force range complex.

The undersigned, for themselves individually, and their marital communities, if applicable, for any minor child in their company, have requested permission to enter certain portions of the Goldwater Air Force Range.

**WE HAVE BEEN WARNED** that said range:

- 1) Contains the danger of injury or death due to falling objects, such as aircraft, live ammunition, missiles, etc.
  
- 2) Contains the danger of injury or death due to presence of not-yet-exploded live ordnance laying on or underground.
  
- 3) Contains danger of injury or death from the presence of old mine shafts and other openings or weaknesses, in the earth, as well as other natural and/or man-made conditions which are too numerous to recite herein.
  
- 4) Cannot be feasibly marked to warn the location and nature of each danger.

Upon our own initiative, therefore, and at our own risk, we accept permission to enter this area and, in consideration of such permission do, for ourselves and the heirs, personal representatives and assignee of same, remise, release and forever discharge as well as agree to indemnify and hold harmless, the United States Government and any lessee therefrom and the individuals and corporations who are the lessors of said property and all the officers, agents and employees of said government and corporations from any claim of liability for death or injury arising out of their usage of, or presence upon, said Range in accordance with permission to enter thereon.
